

**PUBLIC UTILITIES REGULATORY COMMISSION (PURC)
PUBLICATION OF ELECTRICITY TARIFF**

IN accordance with the statutory duty to publish rates approved by the Public Utilities Regulatory Commission under Section 19 of the Public Utilities Regulatory Commission Act, (Act 538) this publication is made this April 20, 2001.

1. The Volta River Authority (VRA) shall charge the rates provided for in the First Schedule hereto as Bulk Supply Tariff (BST) to take effect from May 1, 2001 as stipulated in the said First Schedule.
2. The Electricity Company, Ghana (ECG) Limited and Northern Electricity Department (NED) of the Volta River Authority (VRA), shall charge the rates provided for in the Second Schedule hereto as Distribution Service Charge (DSC) to take effect from May, 2001 billing cycle.
3. The Electricity Company, Ghana (ECG) Limited and Northern Electrification Department (NED) of the Volta River Authority (VRA), shall charge the detailed tariffs stipulated in the Third Schedule hereto as End-User Tariffs to take effect from May, 2001 billing cycle.
4. These rates approved shall not be exceeded and shall remain in force until they are changed by the Public Utilities Regulatory Commission.
5. These rates approved by the Public Utilities Commission which took effect from September 1, 1998 for VRA, ECG and NED as published in *Gazette* No. 42 of September 1, 1998 are hereby accordingly revoked and replaced with the following:
