

**PUBLIC UTILITIES REGULATORY COMMISSION (PURC)
PUBLICATION OF ELECTRICITY TARIFFS**

In accordance with the statutory duty to publish rates approved by the Public Utilities Regulatory Commission under Section 19 of the Public Utilities Regulatory Commission Act, 1997, (Act 538), this publication is made this 16th June 2008.

1. The Volta River Authority (VRA) and the Electricity Company of Ghana Limited (ECG) shall continue to charge the rate provided in the First Schedule as the Bulk Generation Tariff in respect of customers in the tariff categories in the Fourth Schedule.
2. The Ghana Grid Company Limited (GRIDCO) shall continue to charge the rate provided in the Second Schedule as the Transmission Service Charge (TSC).
3. The Electricity Company of Ghana (ECG) and the Northern Electricity Department (NED) of the Volta River Authority (VRA) shall continue to charge the rates provided in the Third and Fourth Schedules as the Distribution Service Charge (DSC) and End-User Tariffs (EUT).
4. The Volta River Authority (VRA) and the Electricity Company of Ghana Limited (ECG) shall charge the rates provided in the Fifth Schedule as the BGT, TSC and DSC in respect of customers in the Special Load Tariff—High Voltage (SLT - HV) category to take effect from 1st July 2008.
5. The Volta River Authority (VRA) and the Electricity Company of Ghana Limited (ECG) shall charge the rates provided in the Sixth Schedule as the End-User Tariffs in respect of customers in the Special Load Tariff—High Voltage (SLT—HV) category to take effect from 1st July 2008.
6. These approved rates remain in force until they are changed by the Public Utilities Regulatory Commission.
7. The SLT, - HV rates approved by the Public Utilities Regulatory Commission to take effect from 1st November 2007 for VRA and ECG as published in the Gazette No. 51 are revoked.
8. The Tariffs are in Ghana Pesewas (GHp).
