

**PUBLIC UTILITIES REGULATORY COMMISSION (PURC)**  
**PUBLICATION OF ELECTRICITY TARIFFS:**

In accordance with the statutory duty to publish rates approved by the Public Utilities Regulatory Commission under Section 19 of the Public Utilities Regulatory Commission Act, 1997 (Act 538) this publication is made this 19th October, 2007 to bring to the attention of the consuming public, the tariffs that came into effect from 1st November, 2007.

1. The Volta River Authority (VRA) shall charge the rates provided for the First Schedule hereto as Bulk Supply Tariff (BST) to take effect from 1st November, 2007.
2. The Ghana Grid Company Limited (GRIDCO) shall charge the rates provided for in the Second Schedule hereto as Transmission Service Charge (TSC) to take effect from 1st November, 2007.
3. The Electricity Company of Ghana Limited (ECG) and Northern Electricity Department (NED) of the Volta River Authority (VRA) shall charge the rates provided for in the Third Schedule hereto as Distribution Service Charge (DSC) to take effect from 1st November, 2007.
4. The Electricity Company of Ghana Limited (ECG) and Northern Electricity Department (NED) of the Volta River Authority (VRA) shall charge the rates provided in the Fourth Schedule hereto as End-User Tariffs (EUT) to take effect from the November, 2007 billing cycle.
5. The rates are in Ghana Pesewas (GHp)

*NOTES:*

- The exclusive lifeline block charge for residential consumers is now set at of GHp 9.50/kWh. This shall remain exclusive to lifeline consumers whose consumption is within the 0-50 kWh range. Thus the consumer who exceeds 50kWh per billing cycle of 30 days will not benefit from the lifeline tariff.

2. Consumption from 51-300 kWh will attract a tariff of GHp 12.00 per unit for residential and GHp 14.00 per kWh for non residential for total kWh consumed.
3. Consumption above 300 kWh up to 600 kWh will attract a tariff of GHp 16.00 per kWh for residential and GHp 17.00 per kWh for non residential customers.
4. Consumption above 600 kWh will attract a tariff of GHp 19.00 per kWh for residential and GHp 19.50 per kWh for non residential customers.
5. Each customer class shall pay the service charge specified in the Fourth Schedule.
